*** Please Note: Deposits of \$250.00 are NON-REFUNDABLE and all sales are FINAL. If you cannot keep your puppy for any reason then he/she IS to come back to me at no cost. ***

I (the seller) make no guarantee on the size, weight, height, coat, color, tint, or eye coloring on any puppy or any changes in the above list that may occur. I (the seller) require a \$250 non-refundable deposit to hold your spot in the pick of the litter list or to hold the puppy of your choice. The order of deposits received is the order of pick of litter to hold/reserve a puppy. The only exception to the deposit is if a desired puppy is not produced at the time of birth than that deposit is transferred to the next litter of puppies (pick based on the order of deposits received). The death of your desired puppy will also cause for transferring your deposit to the next litter. Deposits are valid for 3 litters total only. After 3 litters, your deposit is invalid (unless allowed by seller). I (the seller) will not hold a puppy without a deposit unless agreed upon. If you (the buyer) are unable to wait for a future liter or choose not to get a puppy at all, you (the buyer) have chosen to forfeit your deposit and take the loss.

If for some reason, you (the buyer) can not pick up the puppy at eight weeks of age on the scheduled date (unless agreed upon by both parties before hand) and need me (the seller) to hold the said puppy (named above) for a few more days (but not past the age of ten weeks), I (the seller) will be more than happy to do so. However, starting at nine weeks of age there will be an extra \$8.00 charge for each day added to the remaining amount of money owed to cover the cost of food, board, and general care, that must be paid for before the puppy goes home with you (the buyer). After the age of nine weeks old (unless agreed upon before hand by both parties), if the said pup (named above) has not been picked up, the puppy can be resold and your (the buyers) deposit will be forfeited. If I (the seller) have not heard from you when eight weeks old after trying to make plans for a pick up date, then you (the buyer) forfeit your deposit and the said puppy (named above) will be resold. Final payments due are required to be made in cash or money transfer (Cash App, Facebook Pay, Venmo, or PayPal using Friends & Family option) on puppy pick up day. Seller has the right to refuse placement of a puppy at any given time prior to the pup going home if seller feels that the owner is not a good home and fit for the pup.

The puppy (named above) will be in the best of health to the best of my (the sellers) knowledge and experience. The puppies receive de-wormer at 2, 4, 6, & 8 weeks old. All puppies are seen by my (the breeders) veterinarian before going to their new homes and will come with a certified vet certificate. The puppy will also get their first puppy vaccine between the ages of 7.5-8 weeks old with the 5-in-1 puppy shot. It is your (the buyers) responsibility to get the puppy's booster shots done thereafter at ages 12 and 16 weeks old and then once a year after that. Please remember to worm your new puppy every 2 weeks until they are 12 weeks old and then monthly or bi-monthly and as needed.

I (the seller) take every precaution to insure the safety of all our animals, but because we have no control over the animal once it leaves my (the sellers) home and care, I (the seller) accept no responsibility for the death or illness of the puppy which may be brought on by or as a direct result of exposure to other animals and/or the environment as well as the negligence of others. I (the seller) will not be responsible for and under no circumstances pay for any vet bills, shipping costs, room, board, or destruction of property, etc.

I (the seller) do guarantee the health of the puppy from viral diseases for the first 72 hours from the time you (the buyer) and said puppy (named above) leaves my home. However, if you fail to bring your new puppy to a veterinarian within those first 72 hours of taking home the puppy, at your (the buyers) expense, this guarantee will no longer apply. I (the seller) do guarantee the genetic health of the puppy's hips and eyes. The defect will not be honored if found to have developed due to a non-genetic factor such as trauma, stress, neglect, abuse, or too much tension on his/her bones when growing. If the puppy (named above) is diagnosed at/before the time of turning 2 years old with having hip dysplasia or eye cataracts and is proven by your (the buyers) vet to be the cause of a genetic health issue, then I (the seller) will replace your puppy at no cost from one of our current or next available litters (not including any shipping or traveling fees) or will give you (the buyer) a refund of the purchase of the puppy price, the option will be at my (the sellers) choice, less any cost from any exam and vet fees, and accompanied by a veterinarian invoice and statement providing documentation that the defect is 100% from a genetic health defect. After the said puppy (listed above) turns 2 years old our guarantee is invalid. Any claims as a result of this guarantee must be accompanied by a veterinarian statement and any other documentation required by me (the seller). If the puppy has a genetic eye cataracts or genetic hip dysplasia within the first 2 years of age, or has a viral disease within the first 72 hours, then you (the buyer) are to bring back the puppy to me (the seller) to receive either a current or upcoming available puppy or puppy price refund, the choice of which will be at my (the sellers) choice. If you (the buyer) elect to keep the puppy, then no replacement or refunds will be issued and the owner (the buyer) shall be considered to forfeit all claims, unless the seller chooses to provide partial puppy refund or puppy replacement but this is entirely up to the seller.

If the puppy is to be euthanized, you (the buyer) must tell me (the seller) first and make sure that I (the seller) approve and believe everything has been done to save the puppy/dog first. You (the buyer) must provide me (the seller) with the veterinary paperwork stating what he/she is to be euthanized for. If I (the seller) do not feel euthanasia is the best choice, you (the buyer) are to return the puppy/dog to me (the breeder) at no cost. If I (the seller) believe euthanasia is the best option for the puppy/dog then I (the seller) will give you (the buyer) our blessing. If the puppy dies under the age of 10 years old, you (the buyer) must do an autopsy on the puppy/dog at your (the buyers) expense to prove what the puppy died from. I (the seller) am not liable or responsible for any cost that may accrue from the euthanasia or autopsy or any vet care/exams while the dog/puppy is not in my (the sellers) care.

Additionally, this guarantee does not cover well puppy visits, regular vaccines, de-worming, or any other veterinary care or medication. Also, I (the seller) do not cover any parasites what so ever. Parasites can be picked up anywhere, thus I (the seller) am not liable for any responsibilities for any parasites nor do I (the seller) take responsibility for any illness or death caused by any parasites. In addition, this guarantee does not cover any natural or common health issues that is or can normally happen to puppies at any stage of life. All veterinary care is the responsibility of the new owner (the buyer). After the first 72 hours, my (the sellers) viral guarantee will no longer be valid and no money will be refunded or exchanges for another puppy will be made.

I (the seller) recommend getting your puppy neutered/spayed. This helps breeders protect their breeding programs and inbreeding along with helping keep dogs out of the shelter or in bad situations; in addition, it is better and healthier for the puppy and for you (the buyer). I (the seller) recommend getting your puppy neutered/spayed after the age of one year old or if you are able to wait longer then getting the procedure done at 2 years old as 2 years old is the healthiest time for your puppy to have this procedure done.

I (the seller) also believe it is very beneficial for both you (the buyer) and the puppy to enroll him/her in obedience classes. Huskies have a lot of energy and a mind of their own. These classes are a good way for you (the buyer) and the puppy to get a handle on basic commands and for socialization with the other dogs. **All puppies are sold to pet homes ONLY, NO breeding** (unless agreed upon by both parties and we have gone over everything extensively). You (the buyer) agree to provide proper veterinary care, shelter, food, and water for the puppy/dog at all times. You (the buyer) agree not to abuse, neglect, or abandon the puppy/dog at any time of his/her life. If I (the breeder) find that the puppy is being abused, neglected, or is in an unsafe situation, I (the breeder) have full rights to take back the puppy (listed above) with no form of payment given back to the owner. If for some reason you are not able to properly care for you puppy/dog any longer for any reason, you (the buyer) are to bring me (the seller) back the said puppy (listed above) to me at no cost. The puppy/dog (listed above) is **NOT** to be given away, sold, re-homed, abandoned, abused, neglected, etc. at any given time. My (the sellers) puppies were brought into this world with love and will **ALWAYS** have a home with me (the breeder) if they are unable to be cared for by their owner (the buyer). I (the seller) will either keep the puppy/dog or find him/her a new loving and approved forever family.

You (the buyer) agree to keep me (the seller) updated on the puppy at least once a month with updated veterinary care updates and photo updates of the said puppy (listed above). After the puppy turns a year old, you (the buyer) agree to send me (the seller) updated veterinary care updates and photo updates at least every 6 months of the said puppy (listed above). I (the seller) like to stay updated with my puppies I bring into this world and like make sure they are always in the best love and care, and also so I can watch my puppies grow and mature and stay up to date with all of them.

This document acts as a binding contract between you (the buyer) and me (the seller). Upon signing of this contract, both the buyer and seller agree to the terms listed on all 3 pages of the contract and with everything listed above. My (the sellers) name below acts as a signature in the signing of this contract if this contract has been emailed to you (the buyer), otherwise signed. You (the buyer) should retain this contract as the bill of sale for your records.
